

**MINUTES OF THE REGULAR MEETING  
OF THE ETOWAH COUNTY COMMISSION  
ETOWAH COUNTY, ALABAMA  
September 7, 2021**

Commissioner Jamie Grant called the meeting to order on the 7th Day of September, 2021 at 9:00 am with Commissioner Jeffery Washington asking the Prayer and leading the Pledge to the Flag.

**CALL OF ROLL TO ESTABLISH A QUORUM:** The following 5 out of 6 Commission members were at the meeting and accordingly a quorum was present:

**PUBLIC HEARING:** None.

**PUBLIC COMMENTS FROM CITIZENS:** None.

**PUBLIC COMMENTS FROM ELECTED OFFICIALS AND OTHERS:** Probate Judge, Scott Hassell, said the extension of Whitesboro Cemetery required the Commission and Probate to work together. The Health Department approved areas 1 & 2 but areas 3 – 8 were not approved. The request was amended and the Probate Office recommends approval. He also updated everyone on the Mental Health Committee. They have an RFP that is being reviewed by an attorney so that is moving forward. He also discussed an issue his department has with the business license for Real Estate Salesmen. The license is not applied consistently. There was a change in 2018 and they started making real estate agents pay based on their sales or the maximum amount (which is \$300). Everyone paid the same amount prior to 2018. He is just wondering if they should handle it the same way they handle the car salesmen since they also sell to people that live in other locations. They pay \$70. He recommended they go back to however it was prior to 2018 when it was working better because he believes now we have more people that are non-compliant. He also said many people have a license but are not conducting business and the Real Estate Board can give the Probate Office information to let them know who is actually selling. The cost is anywhere from \$50 to \$300 for the County portion at this time. Linda Barrett-Vaughan said realtors also pay a Business License Fee to the municipality based on where their broker is located.

He also said he wanted to move forward on redistricting as soon as they could because he knows Sardis & Southside grew even though the County dropped a little.

**Shane Ellison** said he had contacted East Alabama multiple times and they wouldn’t call back. He said we would move forward as soon as possible.

**Commissioner Jamie Grant** said he was glad to see the number of the deputies working at the jail improving and that we were making headway with that. He also asked everyone to pray for the leadership in the White House and the things that are happening overseas. Also, pray for the people that have Covid or have a sick family member.
