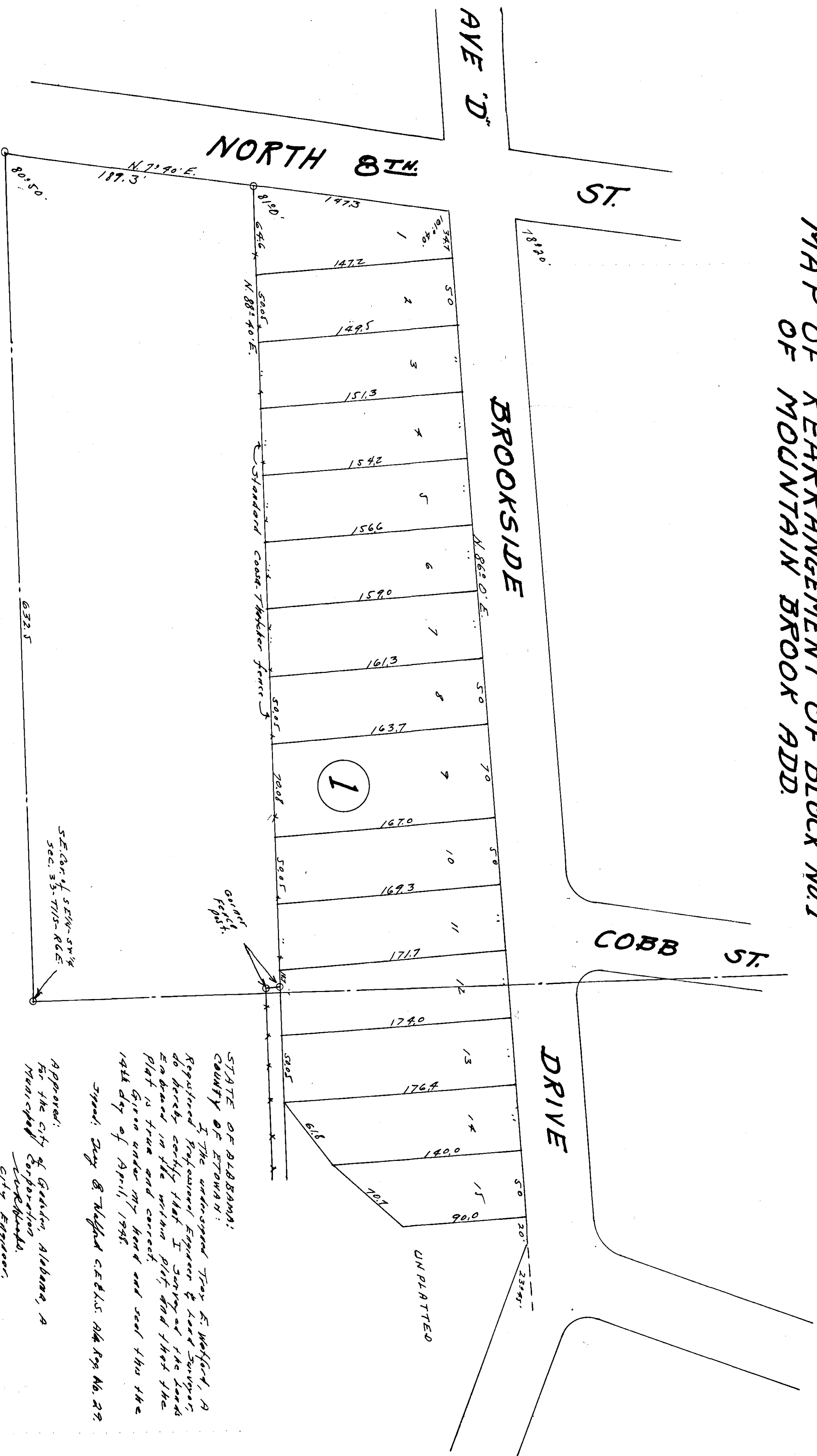


MAP OF REARRANGEMENT OF BLOCK NO. 1
