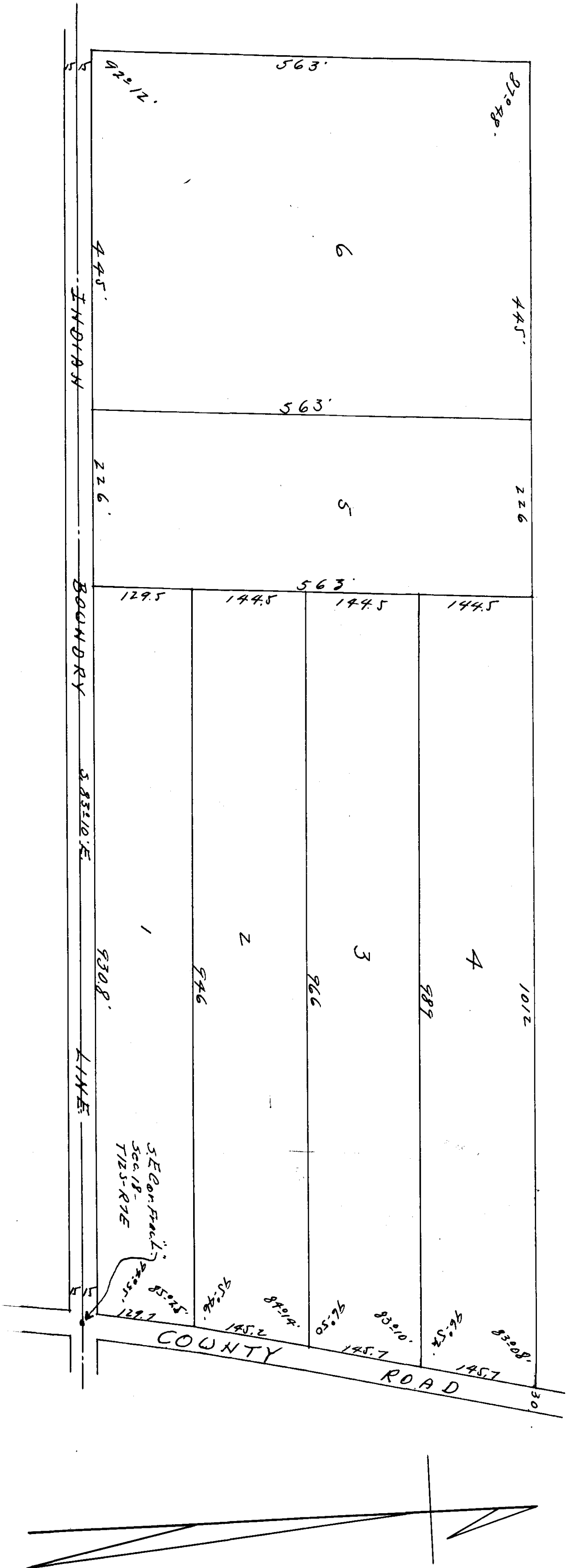


A RE-SURVEY OF LOTS 1 TO 6 INC. OF EMMA & J.P. MARKER
